
City of Northmoor Board of Aldermen

- 3. Approval of the Treasurer's Report for November 2024 as presented.

- 4. Review and approval of a new business license for Computer Plus LLC, owner Dr Solomon Reta. The business is located at 2408 NW Vivion Road. Intended hours of operation are Monday through Friday 9am to 6pm and Saturday 9am to 4pm.

- 5. Mayor Wilson requested approval from the Board of Aldermen to move money from the Utility and General Funds to CD's. Currently have 4 CDs at Central Bank in Riverside at 5% Interest. Mayor Wilson would like to move \$200,000 from the General Fund. Alderman Harris suggests the money be divided up into 1/3's in case the funds were to be needed and terminated before the CD were to mature, which would allow for less of a loss of interest.

- 6. Mayor Wilson asked Aldermen Harris, Griffith and Wright if they are planning to run for re-election on April 8, 2025. Assistant City Clerk, Kim Jones distributed the prepared packets with instructions on how to sign up for re-election. Mayor Wilson asked Alderman Wright if she would run for the 1-year term. The Board of Aldermen were asked not to sign the documents until December 10, 2024, which is the official day to file. Packets are to be returned to Julie at City Hall by December 19, 2024.

DISCUSSION:

- 1. Mayor Wilson provided an update on the following topics:
 - a. Methodist Church Owner is now wanting to split the lot again. The Volleyball and Parking area will be in the back area. There will have to be another Planning and Zoning Meeting and then the recommendations will be presented to the Board of Aldermen for approval.
 - b. Pentecostal Church Aaron Floyd has applied to have a Planning and Zoning Meeting to discuss zoning the said property as C2, for Commercial Use. Once a Date has been scheduled, the Board of Aldermen will be notified.
 - c. The need for a Planning and Zoning Commission alternate was not discussed this evening.
 - d. Durango Repairs have been made on the Durango and it is operational. The vehicle can still be sold as a Police Car with the Cage in the back. Starting price recommended by Mayor Wilson is \$19,500.
 - e. Blacksher Disposal Kevin contacted Mayor Wilson last week and informed her the rate for the Lawrence Landfill had increased 400%, so our rate with the new company, Red Gate Disposal, will more than likely differ from what was initially agreed upon since they use this landfill. Mayor Wilson reviewed the contract between the City and Red Gate, and yes, they can change the rate. Mayor Wilson spoke to Red Gate and was told not to worry about it yet. The rate increases still had to be presented to the Lawrence Council for approval. Utilizing Liberty Landfill could also be an option.
