## **SPECIAL BOARD OF ALDERMEN MEETING MINUTES**

**CALL TO ORDER:** Mayor Wilson called the meeting to order at 6:30PM.

**ROLL CALL:** In attendance were Joe Harris, Robin Griffith and Janeen Wright

#### **DISCUSSION:**

1. The board discussed the Methodist church development. The mayor met with Kim Henry, potential buyer, and Eric Murray, developer. Mr. Murray has several ideas for more development in Northmoor. The mayor asked several other developers in the area about Mr. Murray, and they all gave him good reviews.

### **ACTION ITEMS:**

1. Discussion and approval of Storm Water Grant Matching Proposal. The storm water grant is due on Friday, March 21, 2025. The utilities manager will be submitting the grant application(s) on Thursday, March 20, 2025. The utilities manager presented information to the board regarding the project. All streets in Northmoor will be done, but two streets will only be done to begin the project. Wes Mender suggested that the City of Northmoor agree to match as much money as possible to be considered for the grant. The treasurer presented information to the board regarding available funds. It was noted that percentage amount to be matched can be changed during each phase of the project. Detailed discussion followed. The board agreed to do a 40% match to begin this project.

2. Discussion and approval of Ordinance 2025-003-Ordiance Adopting New Section 520 Non-Residence Design Standards. The city would like to ban all metal buildings except of M-1. Metal buildings will only be accepted for industrial projects. Residential metal storage buildings are limited to 12' X 12'. More detailed discussion followed.
