**WELCOME:** Mayor Wilson welcomed everyone to the meeting and led the Pledge of Allegiance and Prayer

1. No Announcements were made at this time.

**CITY NEWS/CITIZENS COMMENTS:**

**ACTION ITEMS:**

1. Discussion and final approval of the Patty Reynolds building plan and lot split. Ms. Reynolds' attorney, Jerry Brant, was present for this discussion. Emails from Gordon Foulston and Justin Burton were the two issues that were exceptions at the special meeting on October 28, 2025. Both were approved by the Fire Chief and Engineer Burton as being in compliance with city ordinances. The Board of Alderman approved the building plan with an agreement between Mr. Brant and City Attorney, Scott Sullivan. The new plan provides a clipped corner onto 51<sup>st</sup> Terrace. ### DISCUSSION:

1. Discussion regarding yearly inspections on rental properties that are managed by an LLC. The Board of Alderman agreed that this issue will be voted on at the December 2025 meeting.
2. Discussion regarding rental agencies with an LLC needing a yearly business license. At the December 2025 meeting, the board will also discuss and vote on whether the LLC rental properties would need to have a business license, and if they would need to pay a rental fee to the city.
3. Jollene Marten, real estate agent, would like to speak to the board regarding the Peca property. She would like to rezone the property for a four plex. However, Ms. Marten was not present at the meeting.
4. Current speed bumps are receiving complaints about spikes in them. The city has funds available to install permanent speed bumps and the funds are available through Platte County. The Board of Alderman agreed to vote on installing permanent speed bumps at the December 2025 meeting.

8. Review of Invoice for the time period of September 18, 2025 through October 15, 2025 from the Office of the Northmoor City Attorneys. The board reviewed the statement. No discussion was needed.

9. Amanda Jamison wishes to speak to the Board of Alderman regarding operating an Air BnB in Kelly Davenport's property. She was not present at the meeting, so no discussion took place.

### RIVERSIDE FIRE DEPARTMENT:

1. Monthly Report was not provided by the fire chief, so it was not included in Boards packets for their review.

### CITY CODES:

The mayor updated the board regarding codes enforcement for the city. Violation letters have been sent out. The mayor noted that there is a huge problem with open burning throughout the city. Lannette Adamson was present and asked if she could get reports on codes enforcement and if they are profitable. Mayor Wilson responded that codes enforcement is not making money for the city, and she let Ms. Adamson know that she could get information on what the codes enforcement person is paid, how many hours she works, and the revenue that was produced through our court. Mayor Wilson explained that all violations must be given ten days to respond, and another 10 days to be in compliance with city codes. And when the property owner complies, the court did not fine them. Codes enforcement is for cleaning, maintaining or improving the property only, not for making profit. Ms. Adamson stated that she was upset that when her 84-year-old mother's neighbor cut down her mother's tree to the east of her mother's property that the mayor, alderman, and community did not show any support for her mother when she was called names and harassed by said neighbor. The mayor responded that the Ms. Adamson would need to contact the Platte County
